**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Richard W. Forman, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and sprinkler system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**SE¼ NW¼ Section 19, T.12N., R.62E., M.D.B.&M., or at a point from which the SW corner of said Section 19 bears S. 33°31'32" W., a distance of 4,710.13 feet situated in White Pine County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:
