**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Frank C. Hulse, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and sprinkler system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**NE¼ NE¼ Section 33, T.6N., R.66E., M.D.B.&M., or at a point from which the S¼ corner of Section 34, T.6N., R.66E., M.D.B.&M., bears S. 33°42'01" E., a distance of 6,116.16 feet situated in Lincoln County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

30.83 acres in the SW¼ NE¼ of Section 33, T.6N., R.66E., M.D.B.&M.  
30.91 acres in the SE¼ NE¼ of Section 33, T.6N., R.66E., M.D.B.&M.  
**126.05 acres total****

**\*The water under this certificate and any certificates issued under Permits 60016 and 63338 is commingled and shall not exceed 504.20 acre-feet annually for the irrigation of 126.05 acres.**

**\*\*This certificate changes the point of diversion and place of use of a portion of Permit 23958, Certificate 7525, which changed the point of diversion and place of use of Permit 21711, therefore, the date of priority remains the same as Permit 21711.**

**This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.**

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
