CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, James J. Owens, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and sprinkler system for irrigation purposes. The point of diversion of water from the source is as follows:

NW¹ NW¹ Section 11, T.5N., R.66E., M.D.B.&M., or at a point from which the W¹ corner of said Section 11 bears S. 02°45'59" W., a distance of 1,414.81 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Period of use:	January 1st to December 31st of each year

Description of land to which the water is appurtenant:

34.27 acres in the SW¹ NW¹ of Section 11, T.5N., R.66E., M.D.B.&M.
37.75 acres in the SE¹ NW¹ of Section 11, T.5N., R.66E., M.D.B.&M.
2.82 acres in the NW¹ SW¹ of Section 11, T.5N., R.66E., M.D.B.&M.
3.47 acres in the NE¹ SW¹ of Section 11, T.5N., R.66E., M.D.B.&M.
78.31 acres total

***The water under this certificate and any certificates issued under Permits 63113 and 63117 is commingled and shall not exceed 503.24 acre-feet annually for the irrigation of 125.81 acres.**

****This certificate changes the point of diversion and place of use of a portion of Permit 22557, Certificate 7555, which changed the point of diversion of Permit 21614, therefore, the date of priority remains the same as Permit 21614.**

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
