CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George G. Lindesmith, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and irrigation system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**NW<sup>1</sup> NE<sup>1</sup> Section 9, T.22N., R.21E., M.D.B.&M., or at a point from which the NE corner of said Section 9 bears N. 64°50'00" E., a distance of 2,940.0 feet situated in Washoe County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Date of priority of appropriation:	<b>**February 28, 1972</b>

**Description of land to which the water is appurtenant:**

**2.0 acres in the NW<sup>1</sup> NE<sup>1</sup> of Section 9, T.22N., R.21E., M.D.B.&M.**

**\*The total combined duty of water under this certificate and any certificates issued under Permits 63064, 63065, 63072, 63074, 63222, 63223, 63455, 63456, 63708, 64266, 64267, 64268, 64269 and 64270 shall not exceed 151.0 acre-feet annually.**

**\*\*This certificate changes the point of diversion and place of use of Permit 53277, which changed the point of diversion and place of use of a portion of Permit 30116, Certificate 10586, which changed the point of diversion and place of use of a portion of Permit 28072, Certificate 8629, which changed the point of diversion and place of use of Permit 26588, therefore, the date of priority remains the same as Permit 26588.**

**This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per year from any and/or all sources.**

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
