CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Wayne N. Reynolds, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE¼ NE¼ Section 9, T.19N., R.19E., M.D.B.&M., or at a point from which the SE corner of said Section 9 bears S. 19°12' E., a distance of 2,947.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of Use:	Irrigation
Amount of appropriation:	*0.1293 c.f.s., but not to exceed 38.79 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**January 15, 1947

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 600 feet deep, 8 inch diameter casing, via a 40 H.P. submersible pump and motor, thence through a distribution system to the Mountain View Cemetery for irrigation purposes located within portions of the SE¼ NE¼, NE¼ SE¼, SE¼ SE¼, Section 9; and NW¼ SW¼, NE¼ SW¼, SW¼ SW¼, Section 10, T. 19N., R.19E., M.D.B.&M.

\*This certificate is issued supplemental to portions of Claim 119 and 120 Truckee River Final Decree in United States vs. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944).

\*\*This certificate changes the point of diversion, place and manner of use of a portion of Permit 61189, which changed the point of diversion, place of use and manner of use of Permit 11754, Certificate 3077, therefore, the date of priority remains the same as Permit 11754, Certificate 3077.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
