CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Dennis Brazzanovich, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NW¼ Section 24, T.1N., R.46E., M.D.B.&M., or at a point from which the SW corner of said Section 24, bears S. 05° 26' 08" W., a distance of 2714.24 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	2.45 c.f.s., but not to exceed 498.96 acre-feet annually
Period of use:	January 1st to December 31st of each year

30.92 acres in the NW¼ NW¼ of Section 24, T.1N., R.46E., M.D.B.&M.
 31.42 acres in the NE¼ NW¼ of Section 24, T.1N., R.46E., M.D.B.&M.
 30.34 acres in the SW¼ NW¼ of Section 24, T.1N., R.46E., M.D.B.&M.
32.06 acres in the SE¼ NW¼ of Section 24, T.1N., R.46E., M.D.B.&M.
 124.74 acres total

*This certificate changes the point of diversion of a portion of Permit 31540, therefore, the date of priority remains the same as Permit 31540.


This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

This certificate is issued subject to the Amended Stipulation dated February 15, 1984 by Green Ridge Water Company and the State Engineer, Case No. 8694, in the District Court of the Fifth Judicial District of the State of Nevada, Nye County.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
