CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Ross E. de Lipkau, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for mining, milling and domestic purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 26, T.13N., R.32E., M.D.B.&M., or at a point from which the NE corner of said Section 26, bears N. 53° 38' E., a distance of 3,043.0 feet situated in Mineral County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of Use:	Mining, Milling and Domestic
Amount of appropriation:	1.89 c.f.s., but not to exceed *169.776 million gallons annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**February 22, 1984

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 495 feet deep, 12-inch diameter casing, equipped with a 300 H.P. diesel motor, thence to a distribution system for mining, milling and domestic purposes.

Description of land to which the water is appurtenant:

Sections 1 and 2, T.12N., R.32E., M.D.B.&M.

Sections 1 and 12, T.13N., R.31 $\frac{1}{2}$ E., M.D.B.&M.

Sections 3, 4, 5, 6, 7, 8, 9, 10, 15, 16, 17, 18, 19, 20, 21, 22, 23, 25, 26, 27, 29, 30, 34, 35, 36, T.13N., R.32E., M.D.B.&M.

Sections 25, 36, T.14N., R.31 $\frac{1}{2}$ E., M.D.B.&M.

Sections 29, 30, 31, 32, 33, 34, T.14N., R.32E., M.D.B.&M.

*The total combined duty of water under this certificate and Permit 62104, Certificate 16157, shall not exceed 349.228 million gallons annually.

**This certificate changes the point of diversion and place of use of Permit 47706, therefore, the date of priority remains the same as Permit 47706.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
