

**THE STATE OF NEVADA****CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Lisle Lowe, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for commercial (dairy) purposes. The point of diversion of water from the source is as follows:

**NW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 10, T.17S., R.49E., M.D.B.&M., or at a point from which the NE corner of said Section 10 bears N. 87°11'27" E., a distance of 1,979.0 feet situated in Nye County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of Use:	<b>Commercial (Dairy)</b>
Amount of appropriation:	<b>*0.144 c.f.s., but not to exceed 57.50 acre-feet annually</b>
Period of use:	<b>January 1st to December 31st of each year</b>
Date of priority of appropriation:	<b>**February 4, 1980</b>

**Description of the works of diversion, manner and place of use:**

Water is developed by means of a drilled well, 400 feet deep, 12  $\frac{3}{4}$ -inch diameter casing, equipped with a 50 H.P. submersible pump, thence through a distribution system to a 3,000 cow commercial dairy located within the W $\frac{1}{4}$  NE $\frac{1}{4}$  and the NE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 10, T.17S., R.49E., M.D.B.&M.

\*The total combined duty of water under this certificate and Permit 61080, Certificate 15366; Permit 62116, Certificate 16273; Permit 65145, Certificate 16275, and Permit 66042, Certificate 16276, shall not exceed 452.83 acre-feet annually.

\*\*This certificate changes the point of diversion, place of use and manner use of a portion of Permit 40448, therefore, the date of priority remains the same as Permit 40448.

**This certificate is issued subject to the terms of the permit.**

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
