

THE STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Ernest E. Muller, Sr., Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 26, T.34N., R.37E., M.D.B.&M., or at a point from which the E $\frac{1}{4}$ corner of said Section 26, bears S. 18°26' E., a distance of 297.0 feet situated in Pershing County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Period of use:	January 1st to December 31st of each year

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 425 feet deep, 16-inch diameter casing, equipped with a 100 H.P. High Thrust motor and National pump, thence through a distribution system for gated pipe irrigation of the following land:

25.70 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 25.20 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 39.10 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 34.30 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 40.00 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 39.60 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 11.46 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 18.90 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
 19.80 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 26, T.34N., R.37E., M.D.B.&M.
254.06 acres total

*The water under this certificate and Permit 59736, Certificate 16279; Permit 59738, Certificate 16281; Permit 59739, Certificate 16282 and Permit 59740, Certificate 16283 is commingled and the total combined duty shall not exceed 1,016.24 acre-feet annually for the irrigation of 254.06 acres.

**This certificate changes the point of diversion and place of use of a portion of Permit 47346, which changed the point of diversion of a portion of Permit 41482, which changed the place of use of a portion of Permit 25502, Certificate 8696, which changed the point of diversion and place of use of a portion of Permit 22263, therefore, the date of priority remains the same as Permit 22263.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
