CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Vikki F. Riddle, Permittee, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 23, T.19S., R.60E., M.D.B.&M., or at a point from which the NE $\frac{1}{4}$ corner of said Section 23, bears N. 44° 15' 00" E., a distance of 511.0 feet, situated in Clark County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of Use:	Quasi-Municipal
Amount of appropriation:	*0.0044 c.f.s., but not to exceed 2.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**May 25, 1950

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 265 feet deep, 8 5/8-inch diameter casing, equipped with a submersible pump to a storage tank and pressure tank, thence to a distribution system for use on one single family residence with landscaping, pasture, and domestic animals, located within the NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 23, T.19S., R.60E., M.D.B.&M., being further described as Assessor's Parcel Number 125-23-502-012, Clark County, Nevada.

*The total combined duty of water under this certificate and any certificate issued under Permit 68091 shall not exceed 12.0 acre-feet annually.

**This certificate changes the point of diversion and place of use of a portion of Permit 24582, Certificate 7673, which changed the point of diversion and place of use of Permit 13386, Certificate 3949, therefore, the date of priority remains the same as Permit 13386, Certificate 3949.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
