CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gregory M. Bilyeu, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

Lot 3 (NW¼ SW¼) Section 7, T.35N., R.24E., M.D.B.&M., or at a point from which the SE corner of said Section 7, bears S. 64°44'18" E., a distance of 5,643.27 feet situated in Pershing County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: **High Rock Holding, LLC**

Source: **Underground**

Manner of Use: **Irrigation**

Amount of appropriation: ***0.675 c.f.s., but not to exceed 152.12 acre-feet annually**

Period of use: **January 1st to December 31st of each year**

Date of priority of appropriation: ****April 9, 1965**

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 594 feet deep, 16-inch diameter casing, equipped with a submersible pump and a Caterpillar motor, thence through a distribution system for irrigation of:

38.03 acres in the NE¼ NW¼ of Section 7, T.35N., R.24E., M.D.B.&M.

*The total combined duty of water under this certificate and Permit 62245, Certificate 15294; Permit 65190, Certificate 16349; Permit 66594, Certificate 16350; and Permit 66595, Certificate 16351, shall not exceed 1,861.02 acre-feet annually.

**This certificate changes the point of diversion and manner of use of Permit 46202, Certificate 12859, which changed the point of diversion and place of use of a portion of Permit 22532, therefore, the date of priority remains the same as Permit 22532. The reinstated Permit 22532, approved August 1, 1980, pursuant to District Court Amended Order dated August 28, 1979, maintained the original priority date of April 9, 1965.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
