CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Deborah G. Sotero, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from the Truckee River through the North Truckee Ditch for Municipal and Domestic purposes. The point of diversion of water from the source is as follows:

North Truckee Ditch (Glendale Treatment Plant)

Located within the SW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 7, T.19N., R.20E., M.D.B.&M., or at a point from which the NE corner of said Section 7 bears N. 39°28' E., a distance of 3,015.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	The City of Reno, The City of Sparks, Lands of Sierra, Inc., Washoe County Sun Valley Water & Sanitation District, Truckee Meadows Water Authority, and Peppermill Casinos, Inc.
Source:	Truckee River
Manner of Use:	Municipal and Domestic
Amount of appropriation:	6.7253 c.f.s., but not to exceed 806.22 acre-feet as decreed
Period of use:	As Decreed
Date of priority of appropriation:	*1861

Description of the works of diversion, manner and place of use:

Water is diverted from the Truckee River into North Truckee Ditch, treated at the Glendale Treatment Plant and pumped into Truckee Meadows Water Authority's water distribution system.

This system ultimately conveys the treated water to Truckee Meadows Water Authority's water customers within its certified water service area. Said service area is depicted by record (map and legal description), which is filed in the Office of the State Engineer.

\*This certificate changes the point of diversion, place of use and manner of use of a portion of Claim 628, Truckee River Final Decree in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944). Therefore, the date of priority remains the same as Claims 628.

This certificate is subject to Ruling No. 3875, dated March 9, 1992 and specifically subject to the continuing jurisdiction and regulation by the Federal Water Master.

This certificate is subject to the Water Treatment and Distribution Agreement dated October 9, 1989, between the City of Reno and Sierra Pacific Power Company, and to the Water Treatment and Distribution Agreement dated November 13, 1989, between the City of Sparks and Sierra Pacific Power Company, of which Truckee Meadows Water Authority is successor in interest to Sierra Pacific Power Company's responsibility.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
