CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, B. J. Pagano, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for commercial and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ SE¼ Section 22, T.22N., R.21E., M.D.B. & M., or at a point from which the S¼ corner of said Section 22 bears S. 44°29'45" W., a distance of 1430.60 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, that the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of Use:	Commercial and Domestic
Amount of appropriation:	*0.00532 c.f.s., but not to exceed 3.84 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**September 9, 1969

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well 262 feet deep, 6-inch diameter casing, equipped with a 1½ H.P. Fairbanks Morse submersible pump and totalizing meter, thence through a distribution system for drip irrigation of a commercial fruit and berry farm located within portions of the S¼ SE¼ Section 22, T.22N., R.21E., M.D.B. & M.


*The water under this certificate and Permit 66410, Certificate 16548 is commingled and the total combined duty of water shall not exceed 4.96 acre-feet annually for the drip irrigation of various fruit trees and/or berry plants.

**This certificate changes the point of diversion, manner and place of use of Permit 63520 which changed the point of diversion and place of use of a portion of Permit 55975 which changed the point of diversion and place of use of a portion of Permit 30115, Certificate 10585, which changed the point of diversion and place of use of a portion of Permit 28444, Certificate 8632 which changed the point of diversion and place of use of a portion of Permit 25277; therefore, the date of priority remains the same as Permit 25277.

This certificate is issued subject to the terms of the permit with the understanding that a change from drip irrigation to any other type of irrigation will cause this right to revert back to 4.0 acre-feet of water per acre of land irrigated.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
