CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Lisle Lowe, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and sprinkler system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¹/₄ NW¹/₄ Section 23, T.16S., R.48E., M.D.B.&M., or at a point from which the NW corner of said Section 23 bears N. 43°52'55" W., a distance of 1,871 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of use:	Irrigation and Domestic
Amount of appropriation:	*0.145 c.f.s., but not to exceed 50.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**January 3, 1957

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well, 510 feet deep, 14-inch diameter casing, equipped with a 30 H.P. submersible pump and totalizing meter, thence through a distribution system for pivot sprinkler irrigation of the following land:

- 17.24 acres in the NW¹/₄ NW¹/₄ of Section 23, T.16S., R.48E., M.D.B.&M.
- 17.24 acres in the NE¹/₄ NW¹/₄ of Section 23, T.16S., R.48E., M.D.B.&M.
- 17.24 acres in the SW¹/₄ NW¹/₄ of Section 23, T.16S., R.48E., M.D.B.&M.
- 17.24 acres in the SE¹/₄ NW¹/₄ of Section 23, T.16S., R.48E., M.D.B.&M.
- 68.96 acres total**

*The water under Permit 65746, Certificate 16779; Permit 66323, Certificate 16780 Permit 66324, Certificate 16781; Permit 67955, Certificate 16782 and Permit 68451, Certificate 16783 is commingled, and the total combined duty of water shall not exceed 344.8 acre-feet annually for the irrigation of 68.96 acres within the above described place of use.

** This certificate changes the point of diversion and place of use of Permit 63010, which changed the point of diversion and place of use of a portion of Permit 17137, Certificate 5699, therefore the date of priority remains the same as Permit 17137, Certificate 5699.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
