**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Robert E. Morley, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source (EW-34), through a drilled well, pump and distribution system for mining, milling and dewatering purposes. The point of diversion of water from the source is as follows:

**NW¼ NE¼ Section 19, T.36N., R.50E., M.D.B.&M., or at a point from which the NW corner of said Section 19 bears N. 84°04'30" W., a distance of 3,459.97 feet situated in Eureka County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

**Description of the works of diversion, manner and place of use:**

Water is developed by means of a drilled well, 1,710 feet deep, 12-inch diameter casing, equipped with a 240 H.P. Reda motor and a 20 stage Reda pump, thence through a distribution system to Barrick's mine and mill and/or Newmont's mine and mill site (#4 Mill) for Mining and Milling purposes or to a reservoir permitted under J-120 for storage that has secondary permits. The place of use is located within the following.
