CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Dwight L. Smith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source through a drilled well (Well #1), pump and distribution system for recreation (golf course) purposes. The point of diversion of water from the source is as follows:

NW¼ NW¼ Section 36, T.19S., R.61E., M.D.B.&M., or at a point from which the NW corner of said Section 36, bears N. 47°45' W., a distance of 1,396.21 feet situated in Clark County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	Bellagio, LLC, c/o MGM-Mirage Resorts, Inc.
Source:	Underground (Well #1)
Manner of use:	Recreation (golf course)
Amount of appropriation:	*0.029 c.f.s., but not to exceed 15.30 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**August 4, 1945

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 1,340 feet deep, 10 inch diameter casing, equipped with a 25 H.P. motor and a vertical turbine pump, thence through a distribution system to the Shadow Creek Golf Course located within a portion of the NW¼ of Section 36, T.19S., R.61E., M.D.B.&M, being further described as within portions of Assessor's Parcel Numbers 124-36-110-003 and 124-36-510-003, Clark County, Nevada.

*The total combined rate of diversion granted under Permit 61932, Certificate 15806 and Permit 67847, Certificate 16890 is limited to 0.379 c.f.s.

**This certificate changes the point of diversion, manner and place of use of Permit 63604, which changed the point of diversion and place of use of Permit 60732, which changed the point of diversion, manner and place of use of Permit 27835, Certificate 8882, which changed the point of diversion, manner and place of use of a portion of Permit 11347, Certificate 3250; therefore, the date of priority remains the same as Permit 11347, Certificate 3250.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
