CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Rachael Kryder, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and underground sprinkler system for irrigation (Honeysuckle Park) purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 23, T.20S., R.53E., M.D.B.&M., or at a point from which the E¼ corner of said Section 23 bears S. 87°25'00" E., a distance of 2,152.00 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	The Unincorporated Town of Pahrump
Source:	Underground
Manner of use:	Irrigation (Honeysuckle Park)
Amount of appropriation:	*0.058 c.f.s., but not to exceed 12.5 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**April 20, 1965

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well, 425 feet deep, 10-inch diameter casing, equipped with a 25 H.P. submersible pump, two (2) pressure tanks and totalizing meter, thence through a distribution system for underground sprinkler irrigation of the following land:

- 1.18 acres in the SE¼ NW¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 2.69 acres in the SW¼ NE¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 0.24 acres in the SE¼ NE¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 1.67 acres in the NE¼ SW¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 3.87 acres in the NW¼ SE¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 0.85 acres in the NE¼ SE¼ of Section 23, T.20S., R.53E., M.D.B.&M.
- 10.50 acres total**


*The water under Permit 61673, Certificate 16901; Permit 63611, Certificate 16902; and Permit 69511, Certificate 16903 is commingled, and the total combined duty of water shall not exceed 52.5 acre-feet annually for the irrigation of 10.5 acres within the above described place of use.

**This certificate changes the point of diversion and place of use of a portion of Permit 28203, Certificate 8986, which changed the point of diversion and place of use of a portion of Permit 22548, Certificate 7935, therefore, the date of priority remains the same as Permit 22548, Certificate 7935.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
