**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Billy Parson, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation (nursery stock) purposes. The point of diversion of water from the source is as follows:

**SE¼ SE¼ Section 9, T.14S., R.65E., M.D.B.&M., or at a point from which the SW corner of said Section 9, bears S. 83°05'02" W., a distance of 4,094.34 feet situated in Clark County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

**Description of the works of diversion, manner and place of use:**

Water is developed by means of a drilled well, 196 feet deep, 10-inch diameter casing, equipped with a 1½ H.P. Sta-Rite submersible pump and totalizing meter to a pressure tank, thence through a distribution system for sprinkler and drip irrigation of nursery stock located within a portion of the SE¼ SE¼ Section 9, T.14S., R.65E., M.D.B.&M., being further described as Assessor's Parcel Number 030-09-801-005, Clark County, Nevada.


\*The water under Permit 71026, Certificate 16914 and Permit 71344, Certificate 16915 is commingled, and the total combined duty of water shall not exceed 10.06 acre-feet annually for the irrigation of nursery stock.

\*\*This certificate changes the point of diversion and place of use of a portion of Permit 63535, Certificate 15773, which changed the place of use of Permit 59255, which changed the place of use of a portion of Permit 43160, Certificate 10168, which changed the place of use of Permit 12459, Certificate 4017; therefore, the date of priority remains the same as Permit 12459, Certificate 4017.

This certificate is issued subject to the terms of the permit with the understanding that a change from irrigation of nursery stock to any other type of irrigation will cause this right to revert back to 5.0 acre-feet of water per acre of land irrigated.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
