CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gene Moser, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

SW¼ SW¼ Section 16, T.22S., R.61E., M.D.B.&M., or at a point from which the SW corner of said Section 16, bears S. 41°27'00" W., a distance of 1,463.0 feet situated in Clark County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Date of priority of appropriation:	*August 4, 2004

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 250 feet deep, 8-inch diameter casing, equipped with a 2 H.P. Franklin submersible pump, pressure tank and totalizing meter, thence through a distribution system for additional quasi-municipal water service to one home with pool and associated landscaping located within a portion of the SW¼ SW¼ Section 16, T.22S., R.61E., M.D.B.&M., being further described as Assessor's Parcel Number 177-16-402-002, Clark County, Nevada. Water under this certificate also serves the associated landscaping and sparse pasture on Assessor's Parcel Number 177-16-402-003 located within the same legal subdivision.

*This certificate changes the point of diversion and place of use of a portion of Permit 24582, Certificate 7673, which changed the point of diversion and place of use of Permit 13386, Certificate 3949. The date of priority was established in accordance with NRS 533.395 (3) by the cancellation rescission hearing of September 14, 2005.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
