CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Jack D. Ferris, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation, domestic and stock watering purposes. The point of diversion of water from the source is as follows:

NE¼ NE¼ Section 13, T.18N., R.19E., M.D.B.&M., or at a point from which the NE corner of said Section 13 bears N. 48°22'00" E., a distance of 845 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well, 280 feet deep, 6 inch diameter casing, equipped with a 15 H.P. submersible pump and totalizing meter, thence through a distribution system for flood irrigation of the following land:

26.50 acres in the NE¼ NE¼ of Section 13, T.18N., R.19E., M.D.B.&M.
20.25 acres in the SE¼ NE¼ of Section 13, T.18N., R.19E., M.D.B.&M.
46.75 acres total

*The water under Permit 64100, Certificate 16955; Permit 64101, Certificate 16956; Permit 67598, Certificate 16957; Permit 68434, Certificate 16958 and any certificate issued under Permit 71949 is commingled, and the total combined duty of water shall not exceed 193.72 acre-feet annually for the irrigation of 46.75 acres within the above described place of use.

**This certificate changes the point of diversion and place of use of a portion of Permit 61160, which changed the point of diversion and place of use of Proof V04689, therefore the date of priority remains the same as Proof V04689.

This certificate is issued subject to the terms of the permit and totally supplemental to Truckee River Claims 76 and 76A, with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources and further subject to any matter of determination of the relative rights of the Truckee Meadows Hydrographic Groundwater Basin.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.

This certificate is issued subject to the terms of the permit and totally supplemental to Truckee River Claims 76 and 76A, with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources and further subject to any matter of determination of the relative rights of the Truckee Meadows Hydrographic Groundwater Basin.
