CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Dwight L. Smith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well (Well #3), pump and distribution system for commercial and domestic purposes. The point of diversion of water from the source is as follows:

NW¼ NE¼ Section 13, T.20N., R.23E., M.D.B.&M., or at a point from which the NW corner of said Section 13, bears N. 22° 48' 15" W., a distance of 1,419.82 feet, situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground (Well #3)
Manner of use:	Commercial and Domestic
Amount of appropriation:	*0.0214 c.f.s., but not to exceed 15.5 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**April 17, 1998

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 620 feet deep, 8-inch diameter casing, equipped with a 20 H.P. Berkley submersible pump, totalizing meter and storage tanks, thence through a distribution system for an office, maintenance and training facilities and dust control, in support of earthmoving and construction equipment training located within portions of the NE¼ and NE¼ SE¼ Section 13, T.20N., R.23E., M.D.B.&M., lying North of the northerly right of way line of Interstate 80, Section 13 being further described as Assessor's Parcel Number 084-281-04, Washoe County, Nevada.

*The total combined duty of water under Permit 67196, Certificate 17002, Permit 67198, Certificate 17003 and Permit 68663, Certificate 17004 shall not exceed 62.0 acre-feet annually.

**This certificate changes the point of diversion and place of use of Permit 67197, which changed the manner of use of Permit 49412, which changed the point of diversion, manner and place of use of a portion of Permit 35966. The date of priority was established in accordance with the State Engineer's Ruling No. 4762, dated August 10, 1999 for Permit 49412.


This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
