CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard W. Forman, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 8, T.25N., R.65E., M.D.B.&M., or at a point from which the NE corner of said Section 8 bears N. 04°40'05" E., a distance of 1,224.06 feet situated in White Pine County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	*1.32 c.f.s., but not to exceed 568.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**August 27, 1964

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well, 344 feet deep, 16-inch diameter casing, equipped with a 50 H.P. Baldor motor, pump, and a 15 H.P. Baldor booster pump, thence through a distribution system for flood irrigation of the following land:

26.8 acres in the Lot 1	of Section 5, T.25N., R.65E., M.D.B.&M.
35.9 acres in the Lot 2	of Section 5, T.25N., R.65E., M.D.B.&M.
15.6 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$	of Section 5, T.25N., R.65E., M.D.B.&M.
25.6 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$	of Section 5, T.25N., R.65E., M.D.B.&M.
30.7 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$	of Section 5, T.25N., R.65E., M.D.B.&M.
35.3 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$	of Section 5, T.25N., R.65E., M.D.B.&M.
35.8 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$	of Section 8, T.25N., R.65E., M.D.B.&M.
37.0 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$	of Section 8, T.25N., R.65E., M.D.B.&M.
<u>242.7</u> acres total	

*The water under Permit 45434, Certificate 17156; Permit 45435, Certificate 17157 and Permit 43436, Certificate 17158 is commingled and the total combined duty shall not exceed 728.1 acre-feet annually for the irrigation of 242.7 acres within the above described place of use.

**This certificate changes the place of use of Permit 22212, Certificate 7759, therefore the date of priority remains the same as Permit 22212, Certificate 7759.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 3.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
