CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Charles Muratore and Arlene Muratore, Permittees, have presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE¼ NW¼ Section 7, T.44N., R.34E., M.D.B.&M., or at a point from which the SE corner of said Section 7 bears S. 45°32'21" E., a distance of 3,897 feet situated in Humboldt County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Source: **Underground**
 Manner of use: **Irrigation and Domestic**
 Amount of appropriation: ***2.16 c.f.s., but not to exceed 542.40 acre-feet per season**
 Period of use: **April 1st to October 31st of each year**
 Date of priority of appropriation: ****April 13, 1955**

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well 410 feet deep, 16-inch diameter casing, equipped with a 100-HP GE motor, Johnston pump and totalizing meter, thence through a distribution system for flood of the following land:

*The water under Permit 16376, Certificate 7537; Permit 66851, Certificate 17195, and Permit 66852, Certificate 17196; is commingled, and the total combined duty of water shall not exceed 542.40 acre-feet per season for the irrigation of 135.60 acres within the above described place of use.

*The total combined duty of water under Permit 16375, Certificate 7687; Permit 16376, Certificate 7537; Permit 21342, Certificate 7133, Permit 66851, Certificate 17195, and Permit 66852, Certificate 17196 shall not exceed 2,479.60 acre feet per season from any and/or all sources.


**This certificate changes the point of diversion and place of use of a portion of Permit 21342, Certificate 7133, which changed the point of diversion and manner of use of Permit 16373, therefore the date of priority remains the same as Permit 16374.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per season from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
