CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Steven Carter, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well (Maybe Well), windmill, pump jack, pump, trough, and reservoir for stockwater purposes. The point of diversion of water from the source is as follows:

SE¼ SE¼ Section 15, T.9N., R.60E., M.D.B.&M., (unsurveyed) or at a point from which the NE corner of Section 1, T.9N., R.60E., M.D.B.&M., bears N. 36°08'25" E., a distance of 18,759.54 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground (Maybe Well)
Manner of use:	Stockwater
Amount of appropriation:	*0.0375 c.f.s., or sufficient to water 1,200 head of cattle
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	May 10, 2000

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 228 feet deep, 6-inch diameter casing, equipped with a windmill, pump jack, 1½ H.P. electric pump and generator to a 4500-gallon trough and reservoir where 1,200 head of cattle water within the SE¼ SE¼ of Section 15, T.9N., R.60E., M.D.B.&M., (unsurveyed), being within the Maybe Allotment.

***The total combined duty of water under Permit 66344, Certificate 16722; Permit 66345, Certificate 16723; Permit 66346, Certificate 17216; Permit 66347, Certificate 17217; Permit 66348, Certificate 16724; Permit 66349, Certificate 16725; Permit 66350, Certificate 16726; Permit 66351,**



Certificate 17221; shall not exceed the amount sufficient to water 2,500
head of cattle.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be
beneficially used, not to exceed the amount above specified, and the use is
restricted to the place and for the purpose as set forth herein.
