CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Kenneth Marrujo, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from Arizona Spring, through a culvert spring box, pipeline and troughs for stockwater purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 20, T.33N., R.61E., M.D.B.&M., or at a point from which the SW corner of Section 31, T.33N., R.61E., M.D.B.&M., bears S. 25°19'00" W., a distance of 14,760.00 feet situated in Elko County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is diverted from Arizona Spring by a 3-foot diameter vertical culvert spring box and piped to two (2) troughs where 200 head of cattle water within the following:

Lots 1, 2 and 3 Section 1; Lots 2 and 3, SW $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$, and E $\frac{1}{2}$ SW $\frac{1}{4}$ Section 2; All in T.32N., R. 60E., M.D.B.&M.

SE $\frac{1}{4}$, SW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ NE $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$ and NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 25; E $\frac{1}{2}$ NE $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$ and SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 35; NE $\frac{1}{4}$, SE $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$, and NW $\frac{1}{4}$ Section 36; All in T.33N., R. 60E., M.D.B.&M.

SW $\frac{1}{4}$, SE $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, and S $\frac{1}{2}$ NE $\frac{1}{4}$ Section 19; W $\frac{1}{2}$ SW $\frac{1}{4}$ Section 20, S $\frac{1}{2}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ and NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 29; all of Sections 30 and 31, W $\frac{1}{2}$ NW $\frac{1}{4}$ and SW $\frac{1}{4}$ Section 32; All in T.33N., R.61E., M.D.B.&M.

Lots 3 and 4, SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 5; N $\frac{1}{2}$ SE $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, Lots 1, 2, 3, 4 and SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 6; all in T.32N., R.61E., M.D.B.&M., this entire place of use being within the Ruby all in #3 Allotment.


*The date of priority was established in accordance with NRS 533.395 (2) by the cancellation rescission hearing of May 21, 2008.
