**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, George G. Lindesmith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from a underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**SW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 25, T.22N., R.20E., M.D.B.& M., or at a point from which the E $\frac{1}{4}$  corner of said Section 25 bears S. 56°40'23" E., a distance of 2,291.97 feet situated in Washoe County, State of Nevada.**

NOW KNOW YE, that the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

**Description of the works of diversion, manner and place of use:**

Water is developed by means of a drilled well, 560 feet deep, 8-inch diameter casing, equipped with a 30 H.P. Hollow Shaft motor, Berkley pump and totalizing meter, thence through a distribution system for flood irrigation of 4.54 acres and 0.46 acres of pasture grass within a portion of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  and the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , respectively; Section 25, T.22N., R.20E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Number 076-162-05, Washoe County, Nevada

\*The total combined duty of water under Permits 68067, Certificate 17270; 68068, Certificate 17271; 68069, Certificate 17272 and Permit 68070, Certificate 17273 shall not exceed 110.0 acre-feet annually for the irrigation of 27.5 acres.

\*\*This certificate changes the point of diversion of Permit 65727, which changed the point of diversion and place of use of Permit 62605, which changed the point of diversion and place of use of Permit 54469, which changed the point of diversion and place of use of Permit 52573, which changed the point of diversion and place of use of a portion of Permit 30118, Certificate 10588, which changed the place of use of a portion of Permit 28445, Certificate 8519, which changed the point of diversion and place of use of a portion of Permit 25277; therefore, the date of priority remains the same as Permit 25277.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
