CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George G. Lindesmith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from a underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 8, T.22N., R.21E., M.D.B.& M., or at a point from which the NW corner of said Section 8 bears N. 64°35'19" W., a distance of 3,312.50 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, that the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of use:	Irrigation and Domestic
Amount of appropriation:	*0.2 c.f.s., but not to exceed 20.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**February 28, 1972

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well; 800 feet deep, 16-inch diameter casing, equipped with a 350 H.P. U.S. motor, turbine pump and totalizing meter, thence through a distribution system for moveable set sprinkler irrigation of 5.0 acres of lawn sod located within a portion of the NE¼ NE¼ Section 9, T.22N., R.21E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Number 077-100-13, Washoe County, Nevada¹.

*The total combined duty of water under Permit 68845, Certificate 17294; Permit 68847, Certificate 17295 and Permit 68849, Certificate 17296 shall not exceed 100.0 acre-feet annually for the irrigation of 25.0 acres. Rotation in use of water from the well under these certificates and the well under Permit 62889, Certificate 17291 and Permit 62890, Certificate 17292 is allowed under NRS 533.075. This authorization may cease upon the approval of any change application(s) on any of these certificates¹.

**This certificate changes the point of diversion and place of use of Permit 53263, Certificate 13918, which changed the point of diversion and place of use of a portion of Permit 30110, Certificate 10580, which changed the point of diversion and place of use of a portion of Permit 28447, Certificate 8634, which changed the point of diversion and place of use of Permit 28073, which changed the point of diversion and place of use of Permit 26589; therefore, the date of priority remains the same as Permit 26589.


¹Rotation in use is allowed for the diversion rate and duty of water between the two (2) points of diversion and anywhere within the described place of use, as approved under this PERMIT.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
