CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George G. Lindesmith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from a underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 8, T.22N., R.21E., M.D.B.& M., or at a point from which the NW corner of said Section 8 bears N. 64°35'19" W., a distance of 3,312.50 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, that the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Period of use:	January 1st to December 31st of each year

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 800 feet deep, 16-inch diameter casing, equipped with a 350 H.P. U.S. motor, turbine pump and totalizing meter, thence through a distribution system for moveable set sprinkler irrigation of 4.75 acres of lawn sod located within a portion of the NE¼ NE¼ Section 9, T.22N., R.21E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Number 077-100-13, Washoe County, Nevada<sup>1</sup>.

\*The total combined duty of water under Permits 63064, Certificate 15932; 63065, Certificate 15933; 63072, Certificate 15934; 63074, Certificate 15935; 63456, Certificate 15939; 63708, Certificate 15940; 64265, Certificate 15941; 64266, Certificate 15942; 64268, Certificate 15943; 64269, Certificate 15944; 71953, Certificate 17302; 71954, Certificate 17303 71955, Certificate 17304; 71956, Certificate 17305 and Permit 71957, Certificate 17306 shall not exceed 151.0 acre-feet annually<sup>1</sup> for the irrigation of 37.75 acres.


\*\*This certificate changes the point of diversion and place of use of Permit 63222, which changed the point of diversion and place of use of a portion of Permit 54265, which changed the point of diversion and place of use of a portion of Permit 30119, Certificate 10589, which changed the point of diversion of a portion of Permit 28072, Certificate 8629, which changed the point of diversion and place of use of Permit 26588; therefore, the date of priority remains the same as Permit 26588.

<sup>1</sup>Rotation in use of water under this certificate is allowed under NRS 533.075 anywhere within the described place of use, as approved under this PERMIT. This authorization may cease upon the approval of any change application(s) on any of these certificates.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
