CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, John H. Milton III, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 35, T.39N., R.36E., M.D.B.&M., or at a point from which the NE corner of said Section 35 bears N. 36°59'22" E., a distance of 2,479.14 feet, situated in Humboldt County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Period of use:	January 1st to December 31st of each year

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well 504 feet deep, 16-inch diameter casing, equipped with a 150 H.P. U.S. Electric motor, Goulds pump and totalizing meter, thence through a distribution system for pivot sprinkler irrigation of the following land:

*The water under Permit 71070, Certificate 17337; Permit 71071, Certificate 17338 and Permit 71072, Certificate 17339 is commingled, and the total combined duty of water shall not exceed 888.00 acre-feet annually for the irrigation of 234.64 acres within the above described place of use.

**This certificate changes the place of use of Permit 43165, Certificate 10853, which changed the point of diversion and place use of a portion of Permit 22491, Certificate 7699; therefore, the date of priority remains the same as Permit 22491, Certificate 7699.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 3.78 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
