CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Stephen F. Turner, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

Gov. Lot 3, Section 12, T.17S., R.48E., M.D.B.&M., or at a point from which the E¹/₄ corner of said Section 12 bears N. 44°41' E., a distance of 69.1 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 205 feet deep, 14-inch diameter casing, equipped with a pump and totalizing meter, thence through a distribution system for sprinkler and flood irrigation of 14.2 acres of grass, alfalfa and orchard located within a portion of Gov. Lot 3, Section 12, T.17S., R.48E., M.D.B.&M.

*The water under Permits 63565, Certificate 17362; 63566, Certificate 17363; 65473, Certificate 17364 and Permit 65474, Certificate 17365 is commingled and the total combined duty shall not exceed 65.68 acre-feet annually for the irrigation of 14.2 acres within the above-described place of use.

**This certificate changes the point of diversion and place of use of Permit 60465, which changed the point of diversion and manner of use of a portion of Permit 17657A01, Certificate 6978; therefore, the date of priority remains the same as Permit 17657A01, Certificate 6978.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
