CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Karen L. Hardy, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 12, T.16N., R.21E., M.D.B.&M., or at a point from which the SW corner of said Section 12 bears S. 61°06' W., a distance of 1,809 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of use:	Irrigation
Amount of appropriation:	*0.1667 c.f.s., but not to exceed 40.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**May 17, 1972

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 330 feet deep, 10-inch diameter casing, equipped with a 75 H.P. US motor, Johnston pump and totalizing meter, thence through a distribution system for flood irrigation of pasture on the following land:


*The total combined duty of water under Permit 71484, Certificate 17375 and Permit 71485, Certificate 17376 shall not exceed 40.0 acre-feet annually for the irrigation of 10.0 acres within the above-described place of use.

**This certificate changes the point of diversion and place of use of a portion of Permit 26729, Certificate 8957, therefore the date of priority remains the same as Permit 26729, Certificate 8957.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
