**CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Karen L. Hardy, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from the Carson River (Main) through the Upper Cardelli Ditch, ditches and laterals for as decreed purposes. The point of diversion of water from the source is as follows:

**Upper Cardelli from west bank in NE corner, SE $\frac{1}{4}$  SE $\frac{1}{4}$  Section 14, T.16N., R.21E., M.D.B.&M. situated in Lyon County, State of Nevada.**

**NOW KNOW YE**, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:


