CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Catherine E. White, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from Reinken Spring No. 1, an improved spring, submerged spring tank, discharge pipe and storage tank for domestic purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 29, T.18N., R.23E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$ corner of said Section 29 bears S. 11°37'E., a distance of 2,558 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of use:	Domestic
Amount of appropriation:	*0.0062 c.f.s., but not to exceed 4.48 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**January 28, 1955

Description of the works of diversion, manner and place of use:

Water is diverted from Reinken Spring No. 1 by means of a 4-foot diameter by 10-foot deep perforated bottom fiberglass tank partially submerged in the current spring discharge (approximately 700 feet southwest and down-gradient of the surveyed point of diversion) and gravity fed through a 1½-inch poly pipe to a storage tank for domestic purposes to one single-family residence including a pool and spa or to smaller drip irrigation lines for the associated landscaping located within a portion of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 29, T.18N., R.23E., M.D.B.&M., being further described as Assessor's Parcel Number 015-03-37, Lyon County, Nevada.


*The total combined duty of water under Permit 57319, Certificate 17383 and Permit 57320, Certificate 17384 shall not exceed 4.48 acre-feet annually for domestic purposes to one (1) single family residence on the above-described parcel.

**This Certificate changes the manner of use of Permit 16010, Certificate 4613, therefore the date of priority remains the same as Permit 16010, Certificate 4613.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
