**CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Robert E. Morley, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**SW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 23, T.28N., R.52E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$  corner of said Section 23 bears S. 45°25'25" W., a distance of 1,328.00 feet situated in Eureka County, State of Nevada.**

**NOW KNOW YE**, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

**Water is developed by means of a drilled well, 275 feet deep, 14-inch diameter casing, equipped with a 100 H.P. GE motor and Western pump, thence through a distribution system for pivot sprinkler irrigation of meadow hay on the following land:**

\*The water under Permit 59776, Certificate 17386; and Permit 59777, Certificate 17387 is commingled and the total combined duty shall not exceed 860.72 acre-feet per season for the irrigation of 255.74 acres within the above-described place of use.

\*\*This certificate changes the place of use of Permit 24359, Certificate 8671, therefore the date of priority remains the same as Permit 24359, Certificate 8671.

This certificate is issued subject to the terms of the permit and partially supplemental to a portion of Proof 00308, In the Matter of the Determination of the Relative Rights of the Waters of the Humboldt River Stream System and Tributaries, Case No. 2804, Sixth Judicial District Court of Nevada, In and for the County of Humboldt, 1923 - 1938.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
