**CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Dennis Cawrse, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

**SE¼ SE¼ Section 21, T.26N., R.43E., M.D.B.&M., or at a point from which the SE corner of said Section 21 bears S. 44°44' E., a distance of 1,411.0 feet situated in Lander County, State of Nevada.**

**NOW KNOW YE**, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

**Water is developed by means of a drilled well, 400 feet deep, 16-inch diameter casing, equipped with a 150 H.P. Newman motor, Worthington pump and totalizing meter, thence through a distribution system for pivot and wheel line sprinkler irrigation of alfalfa on the following land:**

32.54 acres in the NW¼ NE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
33.30 acres in the NE¼ NE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
32.64 acres in the SW¼ NE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
33.29 acres in the SE¼ NE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
40.14 acres in the NW¼ SE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
24.15 acres in the NE¼ SE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
36.98 acres in the SW¼ SE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
3.48 acres in the SE¼ SE¼ Section 21, T.26N., R.43E., M.D.B.&M.  
236.52 acres total


\*The water under Permit 64995, Certificate 17392 and Permit 72626, Certificate 17393 is commingled and the total combined duty shall not exceed 946.08 acre-feet annually for the irrigation of 236.52 acres within the above-described place of use.

\*\*This certificate changes the point of diversion and manner of use of a portion of Permit 68638, which changed the manner and place of use of Permit 18811, Certificate 5501; therefore, the date of priority remains the same as Permit 18811, Certificate 5501.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
