CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, William F. Price, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M., or at a point from which the SW corner of said Section 10 bears S. 44°17' W., a distance of 3,706 feet situated in Lander County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	Dennis Cawrse and Joanne Cawrse, and Dennis M. Cawrse, all as joint tenants
Source:	Underground
Manner of use:	Irrigation
Amount of appropriation:	*0.4712 c.f.s., but not to exceed 147.264 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**September 30, 1975

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 456 feet deep, 16-inch diameter casing, equipped with a 100 H.P. US motor, Fairbanks Morse pump and totalizing meter, thence through a distribution system for pivot sprinkler irrigation of alfalfa on the following land:

00.121 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
00.113 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
32.363 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
31.996 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
31.890 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
31.425 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 10, T.26N., R.43E., M.D.B.&M.
127.908 acres total


*The water under Permits 68637, Certificate 17420; 68639, Certificate 17421; 68640, Certificate 17422; 68641, Certificate 17423 and 68642, Certificate 17424 is commingled and the total combined duty shall not exceed 511.632 acre-feet annually for the irrigation of 127.908 acres within the above-described place of use.

**This certificate changes the point of diversion and place of use of a portion of Permit 64995, which changed the place of use of Permit 53851, which changed the point of diversion of Permit 29689, Certificate 10864; therefore, the date of priority remains the same as Permit 29689, Certificate 10864.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
