

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, David Bramlett, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for quasi-municipal and domestic purposes. The point of diversion of water from the source is as follows:

NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 30, T.19S., R.60E., M.D.B.&M., or at a point from which the N $\frac{1}{4}$ corner of said Section 30 bears N. 50°10'46" W., a distance of 1,081.96 feet situated in Clark County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	*0.01 c.f.s., but not to exceed 0.61 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**November 29, 1954

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 560 feet deep, 5-inch diameter PVC casing, equipped with a 5 H.P. Red Jacket submersible pump and totalizing meter to a 10,000 gallon storage tank and three (3) pressure tanks, thence through a distribution system for quasi-municipal water service to eight (8) single family residences, three with pools, and associated landscaping located within a portion of the NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 30, T.19S., R.60E., M.D.B.&M., being further described as Assessor's Parcel Numbers 125-30-503-030, 125-30-503-031, 125-30-503-032, 125-30-503-033, 125-30-503-034, 125-30-503-035, 125-30-503-036 & 125-30-503-037, Clark County, Nevada.

***The total combined duty of water under Permit 64193, Certificate 17548; Permit 64417, Certificate 17549 and Permit 64463, Certificate 17550 shall not exceed 6.525 acre-feet annually.**

****This Certificate changes the point of diversion, manner and place of use of Permit 15868, Certificate 5254; therefore the date of priority remains the same as Permit 15868, Certificate 5254.**

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
