## CERTIFICATE OF APPROPRIATION OF WATER

**WHEREAS**, Kenneth Scherado, Jr., Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

**NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 2, T.20S., R.60E., M.D.B.&M., or at a point from which the N $\frac{1}{4}$  corner of said Section 2 bears N. 71°13'34" W., a distance of 705.21 feet situated in Clark County, State of Nevada.**

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

**Water is developed by means of a drilled well, 300 feet deep, 8-inch diameter casing, equipped with a 3 H.P. Sta-Rite submersible pump, totalizing meter and two (2) pressure tanks, thence through a distribution system for additional quasi-municipal water service to one single family residence with associated landscaping, located within a portion of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 2, T.20S., R.60E., M.D.B.&M., being further described as Assessor's Parcel Number 138-02-501-005, Clark County, Nevada.**

\*This certificate changes the point of diversion and place of use of a portion of Permit 24582, Certificate 7673, which changed the point of diversion and place of use of Permit 13386, Certificate 3949; therefore, the date of priority remains the same as Permit 13386, Certificate 3949.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
