

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Erik K. Lee, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 22, T.2S., R.35E., M.D.B.&M., or at a point from which the C $\frac{1}{4}$ corner of said Section 22 bears N. 46°25'06" E., a distance of 3,579.05 feet situated in Esmeralda County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	*0.913 c.f.s., but not to exceed 211.25 acre-feet annually
Period of use:	January 1st to December 31st of each year

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 472 feet deep, 16-inch diameter casing, equipped with a 100 H.P. U.S. motor, Goulds pump and totalizing meter, thence through a distribution system for pivot and wheel line sprinkler irrigation of alfalfa on the following land:

**31.62 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 21, T.2S., R.35E., M.D.B.&M.
 30.77 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 21, T.2S., R.35E., M.D.B.&M.
 33.24 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 22, T.2S., R.35E., M.D.B.&M.
26.62 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 22, T.2S., R.35E., M.D.B.&M.
122.25 acres total**


*The water under Permits 69435, Certificate 17639; 69436, Certificate 17640; 69437, Certificate 17641 and Permit 69438, Certificate 17642 is commingled and the total combined duty shall not exceed 611.25 acre-feet annually for the irrigation of 122.25 acres within the above-described place of use.

**This certificate changes the point of diversion, manner and place of use of Permit 36394, Certificate 10402, which changed the place of use of Permit 14635, Certificate, 5335; therefore, the date of priority remains the same as Permit 14635, Certificate, 5335.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
