

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Mary A. Crawley, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well (Hidden Valley Well #5), pump and distribution system for municipal purposes. The point of diversion of water from the source is as follows:

NW¼ SW¼ Section 16, T.19N., R.20E., M.D.B.&M., or at a point from which the W¼ corner of Section 21, T.19N., R.20E., M.D.B.&M., bears S. 02°36'31" W., a distance of 4,453.21 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	Washoe County
Source:	Underground (Hidden Valley Well #5)
Manner of use:	Municipal
Amount of appropriation:	*0.7 c.f.s., but not to exceed 275.79 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**February 4, 1960

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 138 feet deep, 12-inch diameter casing, equipped with a 50 H.P. Hayes submersible pump and totalizing meter, thence through a distribution system for municipal water service to Washoe County's water customers within the place of use approved under the permit as depicted by record (map and legal description), which is filed in the Office of the State Engineer, as it existed at the time of the filing of Application 57874.


*The total combined duty of water under Permit 53247, Certificate 17696, Permit 53248, Certificate 17697, Permit 57874, Certificate 17698, and any certificates issued under Permits 60546, 69388, 71959 and 71960 shall not exceed 1,357.937 acre-feet annually.

**This certificate changes the point of diversion of a portion of Permit 53247, which changed the manner and place of use of Permit 48091, which changed the point of diversion of Permit 44660, which changed the place of use of Permit 27653, which changed the place of use of Permit 25262, which changed the manner and place of use of Permit 22574, which changed the place of use of Permit 19425, which changed the place of use of Permit 18557; therefore, the date of priority remains the same as Permit 18557.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
