

**STATE OF NEVADA****CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Harry R. Ericson, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

**NE¼ NW¼ Section 12, T.18N., R.19E., M.D.B.&M., or at a point from which the NW¼ corner of said Section 12 bears N. 83°39'40" E., a distance of 765.83 feet situated in Washoe County, State of Nevada.**

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

**Water is developed by means of a drilled well, 303 feet deep, 8-inch diameter casing, equipped with a 5 H.P. submersible pump and totalizing meter to a pond and further pumped through a distribution system for sprinkler irrigation of 1.25 acres of pasture, lawn and associated landscaping, located within the NE¼ NW¼ Section 12, T.18N., R.19E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Number 040-650-19, only, Washoe County, Nevada.**

\*This certificate changes the point of diversion and place of use of a portion of Permit 61160, which changed the point of diversion of Proof V04689; therefore, the date of priority remains the same as Proof V04689.

This certificate is issued subject to the terms of the permit and totally supplemental to Truckee River Claim 185, with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre annually from any and/or all sources and further subject to any matter of determination of the relative rights of the Truckee Meadows Hydrographic Groundwater Basin.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
