## CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Andrew Q. Boyd, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from Lamoille Creek through a head gate and ditches for as decreed purposes. The point of diversion of water from the source is as follows:

**SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub> Section 7, T.35N., R.58E., M.D.B.&M., or at a point from which the S<sup>1</sup>/<sub>4</sub> corner of Section 8, T.35N., R.58E., M.D.B.&M., bears S. 89°14'14" E., a distance of 3,218.4 feet situated in Elko County, State of Nevada.**

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:


**Water is diverted from Lamoille Creek by means of a concrete head gate with control boards to a ditch equipped with a rectangular weir and further through laterals for flood irrigation of 188.792 acres of harvest meadow and 26.807 acres of diversified pasture, located within portions of the NE<sup>1</sup>/<sub>4</sub>, S<sup>1</sup>/<sub>2</sub> Section 13; S<sup>1</sup>/<sub>2</sub> Section 14; T.35N., R.57E., M.D.B.&M., and within portions of the W<sup>1</sup>/<sub>2</sub>, NE<sup>1</sup>/<sub>4</sub> Section 18; T.35N., R.58E., M.D.B.&M., as decreed.**

\*This certificate changes the point of diversion of a portion of Proof 00205, In the Matter of the Determination of the Relative Rights of the Waters of the Humboldt River Stream System and Tributaries, Case No. 2804, Sixth Judicial District Court of Nevada, In and for the County of Humboldt, 1923 - 1938, therefore, the date of priority remains the same as Proof 00205.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 3.0 acre-feet per acre per season for harvest and 0.75 acre-feet per acre per season for diversified pasture, as decreed from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place acquired and to the purpose for which acquired.
