CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Sam Nevis, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 23, T.16N., R.19E., M.D.B.&M., or at a point from which the SW corner of said Section 23 bears S. 67°23'45" W., a distance of 2,719.46 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 155 feet deep, 8-inch diameter casing, equipped with a 1.5 H.P. Sta-Rite submersible pump and totalizing meter, thence through a distribution system for irrigation and domestic use of the following land, being further described as a portion of Assessor's Parcel Number 055-292-03, Washoe County, Nevada.

**1.11 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 23, T.16N., R.19E., M.D.B.&M.
 0.075 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 23, T.16N., R.19E., M.D.B.&M.
 0.24 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 23, T.16N., R.19E., M.D.B.&M.
 0.09 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 23, T.16N., R.19E., M.D.B.&M.
 1.515 acres total**

*The total combined duty of water under Permit 67005, Certificate 17853 and Permit 67006, Certificate 17854, shall not exceed 6.06 acre-feet annually.

**This certificate changes the point of diversion and place of use of a portion of Permit 59758, which changed the point of diversion and place of use of a portion of Permit 20648, Certificate 6086, therefore, the date of priority remains the same as Permit 20648, Certificate 6086.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre of land irrigated annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
