

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, George G. Lindesmith, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for commercial and domestic purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 1, T.20N., R.18E., M.D.B.&M., or at a point from which the SW corner of said Section 1 bears S. 58°34'00" W., a distance of 1,654.62 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of use:	Commercial and Domestic
Amount of appropriation:	*0.0006 c.f.s., but not to exceed 0.4319 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**October 14, 1957

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 602 feet deep, 6-inch diameter casing, equipped with a 1½ H.P. Goulds submersible pump and totalizing meter, thence through a distribution system for commercial and domestic water service to a commercial (real estate) building and residence with associated landscaping, located within a portion of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 1, T.20N., R.18E., M.D.B.&M., being further described as Assessor's Parcel Number 081-031-47, Washoe County, Nevada.

*The total combined duty of water under Permit 63856, Certificate 17937 and Permit 63857, Certificate 17938 shall not exceed 1.102 acre-feet annually.

**This certificate changes the point of diversion, manner and place of use of a portion of Permit 48744, which changed the point of diversion, manner and place of use of a portion of Permit 48386, which changed the point of diversion, manner and place of use of a portion of Permit 34764, which changed the point of diversion, manner and place of use of a portion of Permit 17418, Certificate 5908; therefore, the date of priority remains the same as Permit 17418, Certificate 5908.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
