

CORRECTED CERTIFICATE**STATE OF NEVADA****CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, John Bogard, Permittee, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled artesian well and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 26, T.33N., R.22E., M.D.B.&M., or at a point from which the SW corner of said Section 26 bears S. 84°W., a distance of 1,180 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled artesian well, 100 feet deep, 6-inch diameter casing, equipped with totalizing meter, thence through a distribution system for flood and sprinkler irrigation of meadow and rye grasses on the following land:


*The total combined duty of water under Permit 77782, Certificate 17969; Permit 78054, Certificate 17970; and Permit 79075, Certificate 17971 shall not exceed 102.20 acre-feet annually.

**This certificate changes the place of use of Permit 51639, therefore, the date of priority remains the same as Permit 51639.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre of land irrigated annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
