## CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Carl D. Savely, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for recreation (golf course irrigation) and domestic purposes. The point of diversion of water from the source is as follows:

NW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub> Section 12, T.20N., R.20E., M.D.B.&M., or at a point from which the E<sup>1</sup>/<sub>4</sub> corner of said Section 12 bears N. 87° 7' 25" E., a distance of 2,257 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 432 feet deep, 12-inch diameter casing, equipped with a Berkeley pump, 50 H.P. motor and totalizing meter, thence through an integrated distribution system of storage ponds, pumps and pipelines for sprinkler and drip irrigation of two golf courses and common area landscaping on the following lands:

\*The total combined duty of water under Permit 76972, Permit 81375, Certificate 18805; Permit 81376, Certificate 18806; Permit 81377, Certificate 18807; Permit 81378, Permit 81379, Permit 81380, Certificate 18808; Permit 81381, Certificate 18809; Permit 81382, Certificate 18810 and Permits 81383 and 81384 shall not exceed 609.985 acre-feet annually.

\*The total combined duty of water under Permit 81380, Certificate 18808; Permit 81381, Certificate 18809 and Permit 81382, Certificate 18810 shall not exceed 67.94 acre-feet annually.

Spring water under Permit 76964, Certificate 18746 and Truckee River water under Permit 76975, Certificate 18747 is comingled with underground water under Permit 76972, Permit 81375, Certificate 18805; Permit 81376, Certificate 18806; Permit 81377, Certificate 18807; Permit 81378, Permit 81379, Permit 81380, Certificate 18808; Permit 81381, Certificate 18809; Permit 81382, Certificate 18810 and Permits 81383 and 81384 for irrigation of the above described 341.73 acres.

\*\*This certificate changes the point of diversion of Permit 76970, which changed the place of use of Permit 63475, which changed the point of diversion, manner and place of use of a portion of Permit 53923, which changed the point of diversion of Proof V04884; therefore, the date of priority remains the same as Proof V04884.


The certificate is issued subject to any determination of the underground waters of Spanish Springs Valley, Basin 6-85 that may be made under adjudication proceedings pursuant to NRS 534.100.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
