CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gregory M. Bilyeu, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for Recreation (Golf Course Irrigation) purposes. The point of diversion of water from the source is as follows:

NW¹ SE¹ Section 22, T.16N., R.19E., M.D.B.&M., or at a point from which the SE corner of said Section 22 bears S.38°55'06" E., a distance of 2,451.84 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 595 feet deep, 8-inch diameter casing, equipped with a 25 H.P. Franklin motor, Berkeley submersible pump and totalizing meter, thence through a distribution system for irrigation and ponds on the Thunder Canyon Golf Course within the following lands:


*The total combined duty of water under Permit 66605, Certificate 18841; Permit 66606, Certificate 19082; Permit 66607, Certificate 18192; Permit 66608, Certificate 18193; Permit 66609, Certificate 18669 and Permits 66610, 66611 and 66612 shall not exceed 717.75 acre-feet annually.

**This certificate changes the point of diversion, manner and place of use of a portion of Permit 20648, Certificate 6086; therefore, the date of priority remains the same as Permit 20648, Certificate 6086.

This certificate is issued subject to the terms of the permit and is totally supplemental to Musgrove Creek and Un-named Creek.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
