## CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, A. P. Victors, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from Galena Creek through the Timothy Ditch for as decreed purposes. The point of diversion of water from the source is as follows:

**Timothy Ditch**

SE $\frac{1}{4}$  SW $\frac{1}{4}$  Section 2, T.17N., R.19E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$  corner of said Section 2, bears S. 74°59'06" E., a distance of 1,337.9 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	The A.P. Victors Trust and the Victors Family Trust B
Source:	Galena Creek via the Timothy Ditch
Manner of use:	As Decreed
Amount of appropriation:	*0.0281 c.f.s., but not to exceed 5.0 acre-feet as decreed
Period of use:	As Decreed
Date of priority of appropriation:	**April 1, 1865

Description of the works of diversion, manner and place of use:

Water is diverted from Galena Creek, through the Timothy Ditch, Parschall flume, pipeline, meter and pond, thence through a distribution system for sprinkler and drip irrigation of 0.84 acres of landscaping located within a portion of the NE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 11 and 0.28 acres of landscaping located within a portion of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 12, T.17N., R.19E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Number 148-122-16, Washoe County, Nevada.

\*The water under Permit 79493, Certificate 19133 and Permit 80007, Certificate 19134, is commingled and the total


combined duty shall not exceed 7.0 acre-feet as decreed for the irrigation of 1.56 acres.

**\*\*This certificate changes the point of diversion and place of use of a portion of Claim 651, Truckee River Final Decree, in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944), therefore the date of priority remains the same as Claim 651.**

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.50 acre-feet per acre as decreed from all sources and is subject to the continuing jurisdiction and regulation by the Federal Water Master and State Engineer.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
