

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Bruce R. Scott, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well(well #6), pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 24, T.3S., R.60E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$ corner of said Section 24 bears S.11°15'41"W., a distance of 1,090.64 feet situated in Lincoln County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 700 feet deep, 16-inch diameter casing, equipped with a 200 H.P. Emerson motor, National submersible pump and totalizing meter, thence through a distribution system for pivot sprinkler irrigation of corn, oats, wheat and barley on the following land:

*The water under Permit 79484, Certificate 19374; Permit 79485, Certificate 19375; Permit 81872, Certificate 19383; Permit 81873, Certificate 19384; Permit 81874, Certificate 19385 and Permit 81875, Certificate 19386 is commingled and the total combined duty shall not exceed 1,501.40 acre-feet annually for the irrigation of 300.28 acres within the above described place of use.

**This certificate changes the point of diversion and place of use of a portion of Permit 79034, which changed the point of diversion and place of use of a portion of Permit 69085, which changed the point of diversion and place of use of Permit 64327; therefore, the date of priority remains the same as Permit 64327.

This certificate is issued subject to the terms of the permit with the understanding that the total annual duty of water shall not exceed 5.0 acre-feet per acre of land irrigated from all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
