CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gregory M. Bilyeu, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an unnamed spring, underground collection system, ponds and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NE¹/₄ SW¹/₄ Section 8, T.14N., R.20E., M.D.B.&M., or at a point from which the SW corner of said Section 8 bears S. 29°12'50" W., a distance of 2,967.41 feet situated in Douglas County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of works of diversion, manner, and place of use:

Water is diverted from an unnamed spring by means of a buried drain system, thence diverted and stored in a series of ponds, thence through a distribution system for sprinkler irrigation of the Sunridge Golf Course on the following land:


*The water under Permit 58890, Certificate 19579; Permit 58891, Certificate 19580; and Permit 58892, Certificate 19581; is commingled and the total combined rate of diversion and duty of water shall not exceed 0.2 cfs and 116.56 acre-feet annually for the irrigation of the above-described place of use.

*The water under Permit 51016S03, Certificate 19578; Permit 58890, Certificate 19579; Permit 58891, Certificate 19580 and Permit 58892, Certificate 19581 is commingled and the total combined duty shall not exceed 419.24 acre-feet annually for the irrigation of 115.54 acres within the above-described place of use.

This certificate is issued subject to the terms of the permit and with the understanding that the total annual duty shall not exceed 4.0 acre-feet per acre of land irrigated from all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
